DHT/CABLE MODEM RENTAL AGREEMENT

The **CUSTOMER** agrees:

1. That YourLink Inc. is hereby authorized to make credit inquiries at any time in connection with the credit hereby applied for.
2. To provide YourLink Inc. with a security deposit on the Digital Home Terminal (DHT) in the form of a valid credit card or \$150.00 cash for the duration of the Rental Agreement and authorizes YourLink Inc. to charge any arrears to the CUSTOMER'S card or deposit as applicable.
3. That the DHT and/or cable modem are and shall remain the property of YourLink Inc.
4. That upon termination or default, to return the DHT and/or cable modem to YourLink Inc. in proper, undamaged condition within 24 hours of request and during normal business hours or will allow the office to recover the DHT and/or cable modem from the CUSTOMER during reasonable hours.
5. Should the DHT not be returned in proper, undamaged condition when requested by YourLink Inc., the CUSTOMER shall be liable for the full value of the DHT (\$250.00).
6. Should the DHT be damaged by any third party action, the CUSTOMER will be liable for the replacement value of the DHT (\$250.00).
7. Should the cable modem not be returned in proper, undamaged condition when requested by YourLink Inc., the CUSTOMER will be liable for the full value of the modem (\$150.00).
8. Should the cable modem be damaged by any third party action, the CUSTOMER will be liable for the replacement value of the modem (\$150.00).
9. That YourLink Inc. will not be responsible for any liability or damages caused by a malfunction of the terminal or any part of it, beyond rebate or prorated DHT and service rental charges.
10. This agreement is not assignable or transferable by the CUSTOMER.

YourLink Inc. agrees:

1. That the DHT and/or modem will be serviced or repaired free of charge by YourLink Inc. for as long as the CUSTOMER is in good standing and provided such service or repair is not required as a result of misuse.
2. To consider the CUSTOMER'S obligation to the DHT and/or cable modem as ended if the payments are current and the unit(s) is returned in proper, undamaged condition within 24 hours of termination of agreement and within normal business hours.
3. To return to the CUSTOMER any security held for the DHT upon return of the DHT in proper, undamaged condition.
